## Letter from Etienne Kabila, October 2014

I was never given a break from inhuman and abusive mistreatment I am enduring almost a year and half in KHOSI MAMPURU prison in Pretoria South-Africa.

On August 28th, 2013, my 6-year-old daughter was abducted and traumatized by high rank officer of South Africa police Lieutenant Colonel Noel G Zeeman the investigator in my case. This crime has never been prosecuted by any South African authority.

In this illegal confinement, I spent several months in dimly cell that did not reflect any sun's ray.

Due to that lack of sun which is important for human being. I have had a serious eyes problems, my eyes always dripping some kind of white fluid, even at this particular time, I am writing this letter, I have never receive any adequate medical treatment.

There is not any difference from the prisoners during NAZI era.

The prison guards are authorized by their superiors to torture, assault any time they wish.

On July 19th, 2014 several of my compatriot inmates were viciously assaulted and tortured by task force fully armed, shield wish, electric sticks in front of high hierarchy officers of this prison. The great sorrow that I have is when I see this high hierarchy of the prison exercise by a woman.

Our rights as prisoners are deprived; all privileges are reserved for South African prisoners.

Each one of us is locked 23 hours. Sometimes 24 in the individual cell; Sometimes they refuse to give us hour for exercise, or sometimes we get only half an hour because the dog has to come out. Just to demonstrate that dog has more value than foreigner's prisoners. It reminds me of apartheid when white man valued his dog more than his black worker. And today the black South African values dog more than me, the black foreigner. Apartheid is over, but xenophobia is well alive in South Africa.

Judge Delaray declared my innocence on September 19th, 2013 I am still being illegally detained in prison in this country. You will also understand that my detention has nothing to do with preposterous coup d'état that Mr. Noel ZEEMAN fabricated, but it's merely question of greed and self interest. I am merely political prisoner.
