James Kazongo speaks, Oct 2014

Nearly 2 years since I was abducted and incarcerated in South Africa on February 4, 2013. Daily I experience humiliation and degradation, abusive treatments, tortures, discrimination, xenophobia, and vicious assault.

I am an American citizen, born in the Democratic Republic of Congo, formerly Zaire. After studying in France and Belgium, I moved to USA in 1981, to Philadelphia where I have lived, worked and studied. My family and I made a home in Delaware in 2005, but Philadelphia is my base. I love Philadelphia, I love my home in Delaware, I love America. I am proud to be American, and I am proud that I was born Congolese.

America goes anywhere in the world to defend and protect citizens of other countries from that inhuman behavior, either in their

jails or their streets, America is omnipresent. Iraq was bombed for abusing its own people, Syria got isolated for torturing its own, Libya got waxed for lack of human respect.

Back home in America, I believed that, as an American citizen, I was protected no matter where I am. Until I found myself in prison in South Africa for preposterous and fabricated charges against me scripted and played by high rank South African police. Colonel Noel Graeme Zeeman, Colonel Johan Vanvureen (he told us his name was James Jensen), Colonel illiterate Francois Daniel Conread (Joe Bresler), Nicholas Nick Mr A, Andries Peenar a right hand man of Jacob Zuma, DRC-Congo government were all involved.

During my arrest, I was mercilessly assaulted, while I was handcuffed and blindfolded, I sustained multiple injuries and was never medically attended by any stretch. After being thrown in the prison on February 5th, 2013, the first thing I noticed was the prison ticket had my name, my prison number and sentenced to life written on it.

I have not been through a trial, and yet I have already been sentenced to life. When I was arrested, I was denied phone call, shower, medical treatment, foods for 10 days. I was ordered to stay 24 hours in single cell a size of 45 square feet. I was assaulted 3 months later, in May 2013, by six wardens because I wanted to telephone my family in Delaware. They broke my ankle: during my hospitalization I was denied food for 5 days.

From the beginning of my arrest in February 2013 until July 2014, for 17 months, I was forced to stay in single cell for 23 to 24 hours a day. I was tortured daily, xenophobic language was used often against me, for instance this is not your country, you American you will not go out alive this year I was again assaulted by special police task, dressed to kill with shields, automatic weapons, maze, electric stick they look as though they were going to kill workers in Marikana
